Charles Noonan reported the Highway Crew has been out keeping the roads plowed and sanded after the snow storms. Greene was lucky the highway equipment did not have major breakdowns during these last snow storms. They did go thru a lot of sand and salt as it was not working well in the -20 wind chill weather. They have kept the main roads open and will be going back on the feeder roads the next few days to make room on the roads for more snow.

Charles Noonan reported the Capital Improvement Committee (CIP) met last week and went over the bids. They will be meeting with the apparent low bidder this Wednesday to review the bid and discuss the value of removing some items the town does not need or can do themselves. After joint consultation with the Selectmen and Budget Committee the Selectmen will act on the recommendation of the CIP and award the bid pending Town Meeting approval.
