I. Call to Order

Tony Reny, Acting Chairman, called to order the Public Hearing – Flood Plain Ordinance. The Flood Plain Ordinance was voted on March 2013 and passed. The State notified the Town the accompanying “Flood Insurance Rate Map” dated July 8, 2013 with panels: 118D, 202D, 204D, 206D, 207D, 208D, 209D, 212D, 216D, 217D, 218D, 219D, 226D, 228D, 230D, 236D, 273D, 238D, derived from the county wide digital Flood Insurance Rate Map entitled “Digital Flood Insurance Rate Map, Androscoggin County, need to be changed to E instead of D.

No one from the public was in attendance to comment for or against.

Kevin Mower motioned to amend the National Floodplain Ordinance Article 1 Paragraph 6 The areas of special flood hazard, Zones AE for the Town of Greene, Androscoggin County, Maine identified by the Federal Emergency Management Agency in a report entitled “Flood Insurance Study – Androscoggin County” dated July 8, 2013 with accompanying “Flood Insurance Rate Map” dated July 8, 2013 with panels: 118E, 202E, 204E, 206E, 207E, 208E, 209E, 212E, 216E, 217E, 218E, 219E, 226E, 228E, 230E, 236E, 237E, 238E, derived from the county wide digital Flood Insurance Rate Map entitled “Digital Flood Insurance Rate Map, Androscoggin County,” are hereby adopted by reference and declared to be a part of this Ordinance. 
XIII. Adjournment
