I. Call to Order

Ron Grant - Chairman, called the meeting to order at 7:00PM.

II. Public Discussion

III. Acceptance of Minutes – January 28, 2008

Ron mentioned that more money might have to be allocated at Town Meeting as the Overtime account for the Highway Department was budgeted for \$10,000 for the year and to date \$9,041.94 has been spent. The Highway fuel and equipment repair accounts will be reviewed. After reviewing before town meeting, more money may have to be raised or money cut from other line items in the budget.

V. Roads

The Board discussed having Charlie check with the City of Lewiston on who did the repair on the railroad crossing on Stetson Road. The crossing at Sawyer Road is brutal and getting worse.

VI. Old Business

a. Library Expansion

The library is open for business since last Monday February 4th. There are a lot of books still in boxes as they are short of bookshelves. They have had some computer desks and computers donated.

b. Elections/Town Meeting

Ron Grant announced the election for Selectmen (Anthony Reny and Mark Christman) and MSAD 52 School Board Jon Woodard and Glenn Chateauvert) will be voted on March 7 at Greene Fire Department from 6AM to 7PM. Absentee ballots are available now.

c. Junkyards

The Judge has signed the Delorme agreement; if any deadlines are missed, he will be subject to the \$10,000.00 fine. Tim Doyle thanked Charlie Noonan for working this out without having to go to court; saving the town costs.

d. Snowmobile Road Usage

The Board reviewed the signed agreement and commented the time restraints, valid for one season not one year and trail maintenance are not included in the agreement and need to be amended.


