I. Call to Order

Ron Grant called the meeting to order at 7:00PM.

II. Public Discussion

There was none at this meeting.

III. Acceptance of Minutes – February 23, 2004

MPAC is trying to get things back on track and presented a plan to GE and others to prevent foreclosure on the personal property. MPAC is promising to pay on schedule and if they miss a payment foreclosure process will take place immediately. Steve is to meet with Kim Dutton on February 24th.

d. Fire Station Construction

Plymouth Engineering hired a contractor to fix the walls that were bowed out. The Fire Department is pleased with the fix. After much discussion on the repairs of the building, the building has been fixed at no costs to the Town. Timothy Doyle motioned to pay Glenn Builders \$ 27,248; withholding \$1,500.00 to pay Plymouth until electrical issue resolved. Maurice Levasseur 2nd the motion. Vote was unanimous. Motion passed. Tim Doyle thanked Steve and Ron for settling this issue.

e. Fire Truck Bid

Timothy Doyle motioned to table until the first meeting after the Annual Town Meeting. Mark Christman 2nd the motion. Vote was unanimous. Motion passed.

f. Old Town House/Historical Society

Timothy Doyle motioned to sign the agreement with the Historical Society and to take out the requesting memorandum be recorded. Mark Christman 2nd the motion. Vote was unanimous. Motion passed.

c. Library Bids

Marnie Gardner chairman of the Library Expansion Committee and Steve gave an overview of the bids received. The bids were from \$540,000 to \$690,000. Mark Christman motioned to reject all bids. Timothy Doyle 2nd the motion. Vote for – Maurice Levasseur, Tim Doyle, Ron Grant and Mark Christman. Vote against – Kevin Mower.

Timothy Doyle motioned to allow library committee and Town Manager to discuss with the low bidder (good faith conversation) to keep the discussion open if money is received from a State Library Grant and hold price for the project. Mark Christman 2nd the motion. Vote for the motion – Tim Doyle, Ron Grant, Kevin Mower, and Mark Christman. Vote against – Maurice Levasseur. Motion passed.

Paul Gardner asked that the encumbered funds the town has for the library expansion be released at the Annual Town meeting for expense if needed.
