SELECTMEN'S MEETING MARCH 6, 1995

MINUTES WILL NOT BECOME OFFICIAL UNTIL ACCEPTED AT THE NEXT SELECTMEN'S MEETING ON MARCH 13,1995.

Chairman Tim Doyle opened the meeting at 7:00 P.M., all members were present. Kevin motioned that Dan Moreau be the new chairman of the board. Moe second it and it was unanimous. Dan then called the meeting to order and read the minutes from February 27, 1995. Tim motioned to accept the minutes, Kevin second it and it was unanimous.

- 1. Hills Ridge Road: George Schott requested in writing the Selectmen's position on the Hills Ridge Road. There was discussion and Ed motioned to send Mr. Schott a official copy of the minutes of September 20, 1993 and February 27, 1995 and to have Tim take care of the letter on behalf of the Board. Moe second it and it was Ed, Kevin, Moe, Tim-Yes; Dan abstained.
- 2. Town Manager's Contract: At 7:15 Tim motioned to go into executive session to discuss the Town Managers Contract, Kevin second it and it was unanimous. At 7:30 Dan called the regular meeting back to order. Tim read aloud parts of the contract and Tim motioned to enter into agreement and sign the contract Kevin second the motion and it was unanimous. Dan asked Tom if he is willing to sign and Tom said that he agreed with it and is willing to sign.
- 3. Appointments: The following Appointments were made:
 Tom Richmond Lunch Lumbing and Building Inspector, Tax Collector, Treasurer, Town Manager, Town Clerk and Road Commissioner.
 Sally Ann Hebert: Registrar of Voters. Theodore Webber: Animal Control Officer. Carol Harris: Health Officer. Laurent Veilleux and Roger Begin as Constables. Dave Leeman: Code Enforcement Officer. The Selectmen accepted regretfully a resignation of Warren Mailman from the Julia Morse Library Committee and Appointed Muriel Knowles to replace him.
- 3. Road Postings: Tom told the Selectmen that he and the Road Foreman Gary Mason discussed and started their plans for the the part of the Lane Road that will be worked on this summer.
- 4. Lease Copier: Tom asked the Selectmen to make a decision on the Photo Copier. He said that he had received another bid but it was submitted after the fact. There was discussion and the Selectmen decided it would not be fair to consider the new bid, since it was submitted late and the other bid had been read aloud publicly. Tim motioned to lease the copier from Elliot Office products for the terms specified in the agreement. Kevin second the vote was 4-Yes and Moe abstained.
- 5. Hired Assessor: Tom told the Selectmen that they should get together with the assessor Bob Duplisea to draw up his work

agreement. There was discussion and the Selectmen asked Tom to make the arrangements to meet with Bob.

6. Other: Tom reported to the Selectmen that the Town's Lawyer said the vote at Town Meeting on the Nystrom/Bog Road Issue can not overturn the Selectmen's decision to abandon the road and that only a judge can overturn their decision. Tim asked that it be carried on the agenda.

Selectmen Signed the Weekly Warrants.

Dan read aloud the announcements.

There was public discussion.
