SELECTMEN'S MEETING MARCH 13, 1995

MINUTES WILL NOT BECOME OFFICIAL UNTIL ACCEPTED AT THE NEXT SELECTMEN'S MEETING ON MARCH 20,1995.

Chairman Dan Moreau called the meeting to order at 7:00 P.M., all members were present. Moe read the minutes from March 6, 1995. Ed motioned to accept the minutes, Kevin second it and it was unanimous.

- 1. Treasurer's Report: Tom read aloud the Treasurer's Report and gave a year to date comparison of the 1994 and 1995 income and expenses.
- 2. Roads: Tom reported to the Selectmen that the Salt Shed had been restocked and that the highway crew was working on fixing frozen culverts.
- 3. Lane Road: Randy Ray delivered a petition to the Selectmen and Road Commissioner from the residents on the Lane Road asking them to work on the lower end instead of the part that had originally been planned on. Moe asked Tom what the roads condition will be this year after the work is done. Tom replied that his intentions are that there will be a base coat applied with the finished product put down in 1996, this will allow the culverts to settle.
- 4. Selectmen's Committees: There was discussion and the Selectmen chose which committee they will sit on, as Follows: Dan-Budget Committee

 Kevin-Conservation Committee
- 5. Bog Road\Nystrom Lawsuit: Tom read aloud a letter that was in the Selectmen's packet. It was from a M.M.A. attorney and it discussed the law on "Town Way's", Easements and a example of a case similar to the Nystrom Lawsuit. There was discussion and Moe motioned that Dan talk to Sheldon Bubier on behalf of the board to see what information Sheldon has. Tim second it and the vote was 4-For and 1-against, Kevin.
- 6. Assessor: Tom told the Selectmen that he had made arrangements with the Assessor on behalf of the board for them to meet Wednesday March 15 at the town office at 7:00 P.M..
- 7. Computer Program: Tom reported to the Selectmen that he had worked on the arrangements for the Trio computer tax program. The Town would have to put a \$100.00 deposit on the package and pay the balance of \$1600.00 after taxes go out. This will be a annual cost for the next three years.

8. Other: Tom asked the Selectmen to read a letter from Clyde Hodgkins and to have it on the agenda for discussion next week. The Selectmen appointed Tom as the Assistant General Assistance Administrator.

Selectmen signed the weekly warrants, check #6811 to Knowles Lumber for \$655.33 was voided until the invoices are researched.

Dan read aloud the announcements.

There was public discussion.
