The Board discussed with Bruce Tufts, Fire Chief, the request for proposal for the new fire truck. Bruce and Steve will get together to finalize the proposal for the Board before the April 14<sup>th</sup> meeting.

The Board discussed with Bruce Tufts, Fire Chief, the request for proposal for dispatching services for the Greene Volunteer Fire Department. The Board will receive the final proposal before the April 14<sup>th</sup> meeting.

The Radio Bid will be reviewed after the Dispatching Service Bids are awarded.

### c. Scholarship Committee

The Leavitt Board of Trustees will still award the Greene Bicentennial Scholarship to a Greene Student as before from the interest on the \$16,000.00. The Board of Selectmen is going to form a committee of 4 people and one representative from the Board of Selectmen to award the \$3,000.00 this year to a student graduating from Leavitt. Timothy Doyle is the committee and bring a sample application to the next Board of Selectmen meeting. Brenda Theriault and Christos Gianopoulos was on the Greene Bicentennial. Daniel Kary and Mary Charbonneau have expressed interest of being on that committee.

#### d. Town Office Space Committee

The Town has no money and would like this back on the agenda in four weeks.

#### e. Appointments

Steve reported that our Attorney is filing an contempt of court order against Gerald Marin from the 2000 court decision. He was to remove all structures and clean the site. He is currently residing there in a refrigerated box trailer and just put another box trailer on the property. He applied for a building permit and was denied by the CEO and the money was returned to him.

### g. Other

The Board discussed the White Dove Food Agency is closing down and the food agency is possibly moving over to the Grange to handle and the old town house will be used by the Historical Society. The Board does not want the White Dove Food Agency to shut down as there is a need for a food bank in the Town of Greene.

The Board discussed the paving bids will be put out for proposal.

Ronald Grant wants the Cable Committee to report to the Board what is happening.
