Charlie Noonan reported the Road Crew is patching the roads. Todd Road is thawed out; the more gravel they put on the road the spongier it gets. North Saunders Road had a large culvert collapse; this culvert is 3' across. The road crew is repairing as soon as possible.

The frost heaves are starting to level out. Residents are asked to slow down. The road crew are thawing out frozen culverts.

VI. Old Business

a. TAN Note

Tony Reny motioned to vote (1) That under and pursuant to Title 30-A, Section 5771 of the Maine Revised Statutes, as amended and supplemented, there be and hereby is authorized the issuance of \$1,000,000 principal amount of Tax Anticipation Note of the Town in anticipation of the receipt of taxes for the municipal fiscal year which commended January 1, 2014 and ends December 31, 2014. (2) Said Note shall be dated April 21, 2014, shall mature on December 31, 2014, shall be signed by the Treasurer and countersigned by the Chair of the Select Board, shall bear interest at the rate of .83% per annum, shall be payable at Androscoggin Bank in Lewiston, Maine, and otherwise be in such form and bear such details as the signers may determine. (3) That said Note is hereby sold and awarded to Androscoggin Bank. (4) Said Note is hereby designated a bank qualified tax-exempt obligation of the Town and for the 2014 calendar year pursuant to the Internal Revenue Code of 1986. (5) That all things heretofore done and all action heretofore taken by the Town, its municipal officers and agents in the authorization of said Note and hereby ratified, approved and confirmed and the Treasurer and Chair are each hereby authorized to take any and all action necessary or convenient to carry out the provisions of this voting, including delivering and Note against payment therefor. Kevin Mower 2nd the motion. Vote was unanimous. Motion passed.

b. Stanley Hearing March 25, 2014

Charlie Noonan reported he attended the Hearing; Mr. Stanley did not attend. The Judge dismissed all suits brought against the Town by George Stanley. There is a \$5,000 fine if he opens the business without the proper

licenses and permits. There is also a cease and decease order as well as Court filing and Attorney fees that will have to be paid to the Town of Greene.

The Board discussed if Mr. Stanley could file an appeal with the Maine Supreme Court.

d. Radar Trailer
