## I. Call to Order

## II. Public Discussion

EMA Commend Center was discussed at this point of the meeting. Joanne Potvin, Emergency Management Agency Director, presented to the Board of Selectmen what they would like to house the Decontamination trailer and Commend Center at the Greene Fire Station. Timothy Doyle, Maurice Levasseur & Mark Christman want to hot top Patten Road. Ronald Grant and Kevin Mower want to flex pave Patten Road.

The Steve is to review the bids and what can or cannot be done and report back to the Board at the next meeting on June 14<sup>th</sup>.

# b. Barrell Shop Road Bids

Kevin Mower motioned to reject the one bid received and to turn the project back to Steve to get prices. Mark Christman 2<sup>nd</sup> the motion.

If the railroad fixes the culvert, it will save the town \$5,000.

Timothy Doyle announced that the scholarship committee met and awarded three scholarships (2 - \$1,000 and 1 - \$1,500). More publicity needs to be done on this scholarship.

Kevin Mower motioned to accept and sign the Fire Department Building Warrant of \$ 1,059.00. Mark Christman 2<sup>nd</sup> the motion. Vote was unanimous. The Board discussed this at great length before voting.
