I. Call to order.

Kevin called the final hearing of the Street Naming-Property Numbering Ordinance to order at 6:30 PM.

II. Public Hearing Re: Street Numbering Ordinance.

Alden Peterson gave a rundown of the ordinance. Kevin complimented Alden on the time he has given this project; people don't realize the costs that he has saved the town. The property numbering will take effect 30 days after mailing of the new addresses. Alden reminded Selectmen and Judy that the town needs to update the street signs. Alden is to give Judy the list. Kevin reminded people that the Special Town Meeting is June 3 at 7pm. Kevin concluded final hearing at 6:52 PM.

B. Roads - Judy left copies of bids for tarring/paving Selectmen. Judy reported that Alden Peterson reported to her that the Town will be receiving FEMA for spring washouts. Kevin reported culvert plugged at Allen Pond & Hooper Pond Roads.

C. Solid Waste Contracts - Moe reported Solid Waste Committee held last Wednesday and there is another meeting week from this Wednesday. He asked direction from chair on oversized products. Moe motioned to ask Judy to fax letter to Steve Catir of KTI Bio Fuels LP to send contract for 1st year of \$42.50 and 2nd year of \$45.00, Bill second, and it was unanimous. Moe reported that Lewiston has not committed in writing for the processing of magazines.

D. Agreement on Road Crossing - Judy passed around opening of highways form that the State DOT uses. Judy will pull together one for town use. Judy is to pull the statute and information for next full workshop meeting.

E. Park and Ride Approval - Bill & Judy looked at the site for park and ride. This carried to work session and Judy can draw up plan and look at state funding.

G. Other - Judy reported that she is waiting for the quotes on new stickers that the license plate number can be written on them so doesn't go from one vehicle to another. Judy is to bring quotes to next meeting.,

F. Policy on Building Permit Review - Judy reported that she is passing copies of building permits issued to CEO and Selectmen after issuing. Chairman wants a policy statement.

G. Other (continued) - Judy reported that William Parquette Jr will be meeting with her later this week. Moe motioned if gentlemen is willing and Judy willing amounts to be taken out of permits, Bill seconded, it was unanimous.
