**a. Highway Garage Construction**

Charles Noonan reported the project is in the watershed of Sabattus Pond. A phosphorus plan watershed study has to be submitted to DEP. The Planning Board will go forward Wednesday night; they will be a 2-3 week delay in starting the project.

**b. Bond Proceeds**

Charles Noonan reported that the money will be used as a sweep account. A good portion of the monies will be spent in three months. Interest cannot be spent on anything but paying down the bond principal.

**c. Paving**

Charlie Noonan presented a spread sheet with the three proposals from Allstate Paving, Lane and Pike. Charlie Noonan reported that Pike's quote includes handwork being done at the driveways.

Glenn Chateauvert motioned to award the paving to Pike in the amount of \$932,742.20. John Soucy 2<sup>nd</sup> the motion. Vote was unanimous. Motion passed.
