R & S is going to do digging and take trees down the rubber tired excavator the town has rented cannot do the work on this piece of land where it has been so wet.

There is concern on what will happen to the old town garage. This will be looked at before construction.

The committee will meet with abettors; with concerns in area. They will meet with committee, town manager and board of Selectmen about the concerns of the new Town Garage being built off School Street/Sprague Mills Road.

GYAA is to present the Committee with their needs; design field, and be able to tell the Capital improvement Committee what they want to do.


