

**Greene Board of Selectmen
Regular Meeting
June 27, 2005**

Minutes will not become official until accepted at the next Regular Selectmen's Meeting July 11, 2005.

Members present: Timothy Doyle, Anthony Reny, Kevin Mower, Mark Christman, Ronald Grant – Chairman, and Charles Noonan – Town Manager and Sally Ann Hebert – Recording Secretary.

I. Call to Order

Ronald Grant, Chairman, called the meeting to order at 7:00 PM.

II. Public Discussion

Eric Goodwin of Communities Getting Involved spoke to the Board of Selectmen requesting monies and volunteers to assist in the cleanup of 102 miles of Androscoggin River in August. He is requesting \$350 for the 7 miles in Greene along the river.

Timothy Doyle motioned to have the Town Manager contact the Conservation Committee for volunteers, and to pay the Highway Department employees a couple of hours. Kevin Mower 2nd the motion. Vote was unanimous. Motion passed.

III. Treasurer's Report

Charles Noonan, Town Manager, reported that balance is \$130,644.96 after the today's warrant. The town made it through the month without borrowing money from themselves. The town paid one half of the school payment per agreement with the MSAD 52 business office. The towns revenue and expenses are in good shape. No decision has been made from the federal government on the April rainstorm.

A copy of the Treasurers report will go out to the Budget Committee with cash flow analysis at the end of the month for their review.

V. Roads

Charles Noonan, Town Manager, reported that the highway crew has been doing a lot of work on West Maine Street in preparation for the paving.

Kevin Mower motioned to award West Main Street - binder and reclaim and Wiley Road binder and reclaim to Commercial Pavng. Anthony Reny 2nd the motion.

Vote for the motion – Kevin Mower

Vote against the motion – Anthony Reny, Timothy Doyle, Ronald Grant and Mark Christman. Motion failed.

Anthony Reny motioned to accept the bids and award the total overall price per ton to RC & Sons. Mark Christman 2nd the motion.

Vote for the motion – Anthony Reny, Mark Christman, Timothy Doyle and Ronald Grant.

Vote against the motion – Kevin Mower. Motion passed.

Charles Noonan, Town Manager, reported that he has received a letter from David Cole, MDOT, to set up a meeting with George Jackman on Thursday at 2pm to look at all the railroad crossings in Greene.
