

**Greene Board of Selectmen**

**I. Call to Order**

Timothy Doyle, Acting Chairman, called the meeting to order at 7:00 PM.

**II. Public Discussion**

Earl Gilmore, resident of River Road asked the Board of Selectmen to have the Highway Department leave the bump in the road, as it acts as a speed bump. He also asked the Board to maintain the 5% discount. He also requested that the Highway Department trenches his property from the road. Charles Noonan, Town Manager will look at the situation.

**III. Acceptance of Minutes – June 13 & June 29, 2005**

**V. Roads**

Charles Noonan, Town Manager, reported the highway crew has finished the preliminary work on West Main St. West Main Street and Wiley Road are scheduled to be grinded on July 18<sup>th</sup>. The crew is working on Wiley Road, Bull Run Road to prepare before paving.

Charles Noonan, Town Manager and Bruce Tufts, Road Foreman will be working on the paving schedule for this season.

**a. Truck Bids**

After the Board discussed the truck bids Mark Christman motion to go ahead and follow the recommendation of the Town Manager and Road Foreman and purchase the truck from Morrison-Sylvester for \$ 55,936.10 and to set a date for the special town meeting for additional monies for the plow etc. Kevin Mower 2<sup>nd</sup> the motion. Vote for the motion – Anthony Reny, Kevin Mower, Mark Christman.

Vote against the motion – Timothy Doyle. Motion passed.

Anthony Reny motioned to set a date of July 25<sup>th</sup> at 7pm for special town meeting for the additional funds for the plow, wing and accessories. Mark Christman 2<sup>nd</sup> the motion. Vote was unanimous. Motion passed.

**b. Railroad Crossings**

Charles Noonan, Town Manager, reported that he has met with MDOT, Representative Lansley and the railroad is considering repairing their section of railroad crossings in Greene. MDOT may not have money in their budget to do their repairs at the Sawyer Road crossing but might be able to find the money.
