**I. Call to Order**

Ronald Grant, chairman called the Board of Selectmen's meeting to order at 7:00 PM.

**II. Public Discussion**

Stanley Hinds resident of 331 Route 202 appeared before the Board with his dissatisfaction of not being able to replace his transfer station disposal card that has been lost. He is not able to get a replacement the way the ordinance is written. He pleaded that he has resided in Greene over 10 years, pays over \$3,200 year in taxes, disabled, retired and does not get any consideration. Ron Grant was going to explain to him, but, Mr. Hinds walked out of the meeting.

If the court case is awarded to the Town and the town gets the legal fees and fines; there will be a special town meeting to see how to handle those monies.
