Charlie is to see if there is another vendor that can do the project next year. Three weeks left to do project within the time frame; later date has to go to Army Corp of Engineers because of fish spawn. Carry over the amount at the 2010 Town Meeting. The vender will be responsible for any damage to road as it have to be paved this year. The posted weight limit will still be in effect.

The road crew is working on South Mountain Road; ditching and culvert work. This road will be priority for 2010 road work.

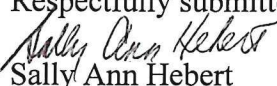
