I. Call to Order

Ron Grant, chairman called the Board of Selectmen's meeting to order at 7:00 PM.

II. Public Discussion

III. Acceptance of Minutes

V. Roads

Charlie reported the road crew installed culverts, hauled in more winter sand and salt, some patching. The road crew will be working at the Transfer Station doing some work where the brush pile is located.

The Board discussed the condition of Patten Road between Main St and Route 202.

The Board discussed the outside lights at the Town Office they keep burning out.

The Board discussed the tires that were dumped by Turner Center Bridge and Cherry Pond.

The Board discussed the bridge washing out on Grey Road at Main Street. Charlie commented it may cost \$100,000 to \$150,000 to replace. Authorization has to be gotten from DEP. The Board may have to close the road if the bridge gets worse. The town cannot do any work on this bridge at this time of year. The road can be closed as there is another way for residents to enter/exit on.

Charlie Noonan is to call the MDOT on the status of the speed limit requests on roads requested three years ago.

V1. Old Business

A. Tax Acquired Property

Charlie reported the quit claim deeds have been prepared by the attorney. One has already come in paid for the property. The other one will be in tonight.

The Board discussed the other property that no bid was received on. George Schott offered \$5,000; the town wanted \$6,000.

Tony Reny motioned to accept George Schott's offer; pending review of the consent order within a reasonable amount of time within the code requirements. Don Bedford 2nd the motion. Vote was unanimous. Motion passed. The consent agreement will go to the Board for final approval.

The grant for the repeater for the fire department was turned down.

Mark Potvin has tendered his notice to end his employment at the Transfer Station. Charlie has posted the position. Someone has been at the transfer station trying the position and he is not supervisor material. Sheldon Bubier and Bob Hodgkin will help out at the Transfer Station.

Charlie is going to work on changing the hours and positions at the Transfer Station.
