In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Greene, in said county, qualified by law to vote in town affairs, to meet at the Municipal Office Building, in said town, on Tuesday the 18th day of February, A.D. 1996 at 7:00 o'clock in the evening, then and there to act on Articles 1 and 2. 97

Article 1: To elect a moderator to preside at said meeting.

Article 2: To authorize the Selectmen to expend up to One Half (1/2) of the budgeted amount of the 1996 Winter Roads Account between January 1, 1997 and the 1997 Annual Town Meeting.


