## 2009 Special TOWN MEETING WARRANT

To Alden Peterson, a resident of the Town of Greene, in the county of Androscoggin,

In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Greene, in said county, qualified by law to vote in town affairs, to meet at the Greene Fire Station, in said Town, on **Wednesday the 16th day of September, A.D. 2009 at 7:00 o'clock** in the evening, then and there to act on Articles 1 and 2.

**Article 1:** To elect a moderator to preside at said meeting.

**Article 2:** To see what sum of money, if any, the Town will vote to raise and/or appropriate for the construction of a new Town Office.

Selectmen and Budget Committee recommend an amount not to exceed \$570,000.00 to be appropriated from the following accounts/sources:



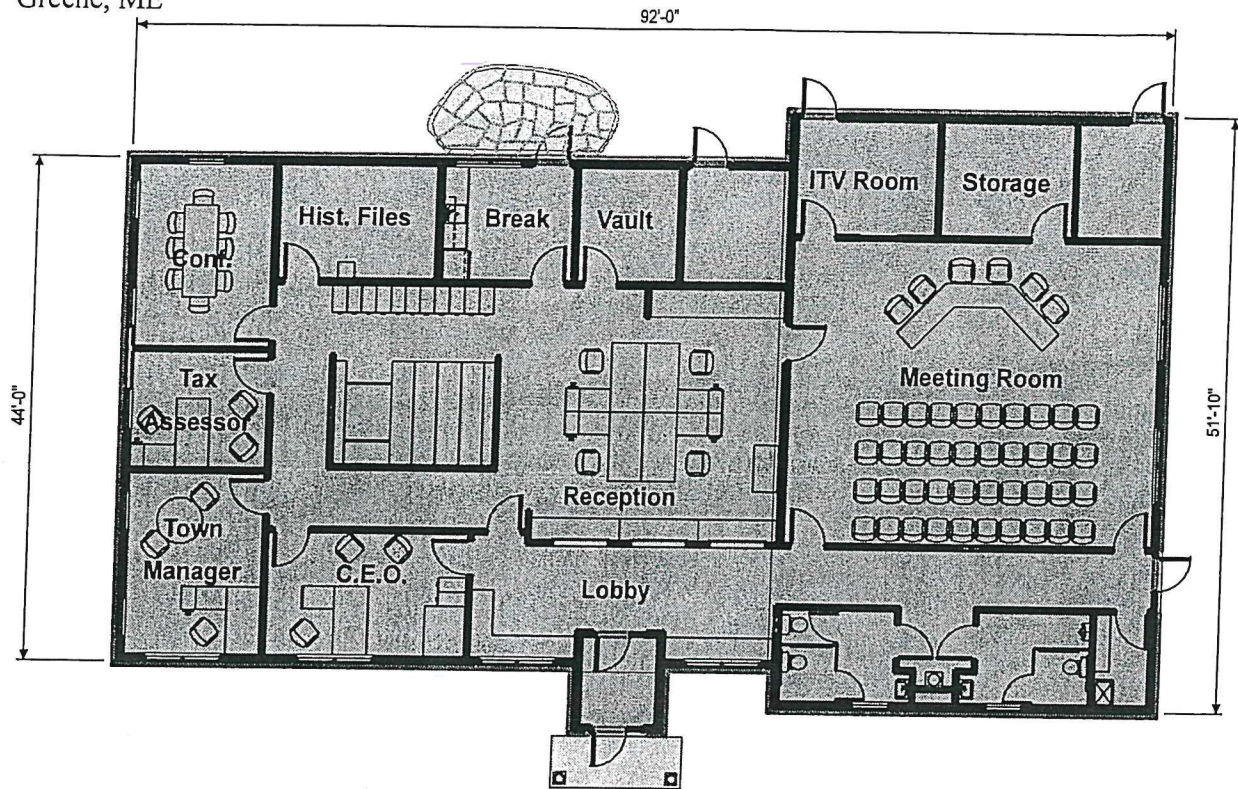
